The Cherokee County Board of Supervisors met in regular session on Tuesday, November 15, 2016 with Dennis Bush, Rick Mongan, Gary Lundquist, Jim Peck, and Jeff Simonsen present. Ken Ross, *Chronicle Times*, represented the press. Jim Haselhoff, Duane Mummert and Stu Hogg were also in attendance.
