The Cherokee County Board of Supervisors met in regular session on Tuesday, August 27, 2019 with Dennis Bush, Rick Mongan, Gary Lundquist, Duane Mummert, and Wane Miller present. Steve Peterson, Aurelia Star, represented the press. William Gauthier, Nathan Corlew, Katelynn DeRoos, Tammy Carlson, Sarah Tracy, Jerod Clyde, Keva Wolf and Cindy Nelson were also in attendance. Cindy Nelson, Deputy Treasurer, presented correspondence regarding tax suspension for an individual.

Motion by Mummert, seconded by Miller to approve a property tax suspension for an individual per DHS guidelines on the following parcel: 90-01-33-458-003. Motion carried.

Sarah Tracy, County Engineer, presented right of way construction permits for consideration.

Motion by Miller, seconded by Lundquist to approve an underground construction on county right of way application for Cherokee Rural Water in Section 20 of Liberty Township. Motion carried.

Motion by Mummert, seconded by Bush to approve an underground construction on county right of way application for Nuvera in Sections 3 and 4 of Afton Township and Sections 14, 15, 16, 20, 21, 22, 23, 24, 25, 26, 27, 28, 29, 32, 33, 34, 35 and 36 of Pitcher Township. Motion carried.

Sheila Letsche, rural Marcus resident, expressed concerns about grain trucks jake braking in front of her home at all hours of the day as they are traveling to and from the ethanol plant. The county engineer had placed signs prohibiting the use of jake brakes on that section of F Avenue three years ago, however, the signs are not regulatory and therefore cannot be enforced by law enforcement. Sarah Tracy, County Engineer, and Nick Patterson, Sign Foreman, are aware of the ongoing problem and will work with Letsche and the Sheriff's Department to determine possible solutions. Letsche asked if a reduced speed zone could be considered for that section of the road. The supervisors advised Letsche to stay in contact with the County Engineer and stated that the county will try to work through this problem.

Motion by Mummert, seconded by Miller to approve a separation of employment for Jacob Zwiefel, Conservation Seasonal Tech, effective August 16, 2019. Motion carried.

Motion by Lundquist, seconded by Bush to approve a separation of employment for James Leonard, Secondary Roads Seasonal Laborer, effective August 16, 2019. Motion carried.
