Motion by Miller, seconded by Bush to approve an underground construction on county right of way application for CML Telephone in Section 24 of Liberty Township. Motion carried.

Motion by Miller, seconded by Lundquist to approve an underground construction on county right of way application for CML Telephone in Section 14 of Liberty Township. Motion carried.

Motion by Lundquist, seconded by Miller to approve an underground construction on county right of way application for CML Telephone in Section 7 of Cherokee Township. Motion carried.

Motion by Bush, seconded by Miller to approve an underground construction on county right of way application for CML Telephone in Section 36 of Cherokee Township. Motion carried.

Motion by Lundquist, seconded by Bush to approve an overhead construction on county right of way application for Iowa Lakes Electric Cooperative in Section 19 of Amherst Township. Motion carried.

Motion by Bush, seconded by Miller to approve an overhead and underground construction on county right of way application for Iowa Lakes Electric Cooperative in Section 7 of Cherokee Township. Motion carried.

Motion by Lundquist, seconded by Miller to authorize the chairman to sign an updated Road Use Agreement for Glaciers Edge Wind Project with the only change being the project name. Motion carried.

Motion by Lundquist, seconded by Bush to appoint Dr. Timothy Rice as Cherokee County Medical Examiner for a two (2) year term ending December 31, 2020. Motion carried.

Motion by Miller, seconded by Lundquist to appoint Ben Schilmoeller as Cherokee County Medical Examiner Investigator effective July 9, 2019 as recommended by Dr. Rice, Medical Examiner. Motion carried.

Motion by Lundquist, seconded by Miller to abate \$712 of interest and penalty on parcel #98-07-26-127-014. Motion carried.

Iowa State Association of Counties (ISAC) representatives Bill Peterson, Lucas Beenken and Jamie Cashman presented an informative review of services provided to counties by the association, including a summary of legislation passed in 2019.

The supervisors provided committee reports and reviewed meeting schedules.
