Sarah Tracy, County Engineer, and Steve Zarr, Engineering Aide, presented nine utility permits for consideration. Zarr explained that each permit maps out circuits to feed numerous turbines and all boring will be placed four feet below the base of county ditches.

Motion by Bush, seconded by Lundquist to authorize the chairman to sign nine underground utility permits for White Construction including 62 different boring locations in the Glacier's Edge Wind Farm Project in Marcus Township. Motion carried.

Bill Anderson, CAEDC Director, and Brian Freed presented an overview of economic development projects and goals for the continued growth of Cherokee County. Anderson thanked the supervisors for their continued financial support and reviewed a new development partnership that is currently being pursued with Plymouth County to combine resources and promote both counties. Freed added that workforce development continues to be the main objective to draw new labor into the area and optimize the current labor force. Matching skill sets of our youth to jobs that are available will be the focus for the next year along with addressing housing needs of a growing workforce.

Motion by Lundquist, seconded by Miller to approve Amendment #2 to a Facility Lease Agreement between the Cherokee Mental Health Institute and Cherokee County Board of Supervisors adding additional conference room space provided by the County for DHS Child Welfare Social Workers. Motion carried.

Motion by Miller, seconded by Bush to approve July 1, 2019 wage increases as follows:

Courthouse Building Custodian, Paul Paltz (2.75%)

County IT Department, Stu Hogg (2.75%)

Community Services Director, Lisa Bringle (3% approved by Rolling Hills Community Services Region Governance Board)

A request was received from the Cherokee Chamber of Commerce for use of two county roadways.

Motion by Lundquist, seconded by Miller to approve a detour on Linden Street and S Avenue for the 53rd Annual Cherokee Chamber PRCA Rodeo Parade on June 1, 2019. Motion carried.

Jerry Weiland, Veteran Affairs Director, presented a wage authorization for consideration.

Motion by Bush, seconded by Lundquist to approve a \$11.00 wage authorization for Darla Good, Part-Time Veteran Affairs Administrative Assistant, for 10 to 15 hours per week effective March 27, 2019. Motion carried.

The supervisors provided committee reports and reviewed meeting schedules.

There being no further business, Chairman Mongan adjourned the meeting at 9:45 a.m.
