The Cherokee County Board of Supervisors met in regular session on Tuesday, October 13, 2020 with Dennis Bush, Rick Mongan, Duane Mummert and Wane Miller present. Gary Lundquist was absent. Nick Brewer, *Chronicle Times*, represented the press. William Gauthier and Stu Hogg were also in attendance. Unless otherwise indicated, all votes were offered as follows: Ayes – Mongan, Bush, Mummert, Miller; Nays – none; Abstentions – none.

Samantha Boothby, County Recorder, presented a revenue report for consideration.

Motion by Bush, seconded by Miller to approve the Recorder's \$65,236.29 September 30, 2020 Quarterly Revenue Report as presented with \$ 26,934.12 retained by the county. Motion carried.

Dave Skou, E911 Director, was unable to attend the meeting so Mongan reported on the completion of equipment installation on the Meriden Tower which remedies "dead zones" previously experienced by county two-way radio systems.

Motion by Mummert, seconded by Miller to approve a separation of employment for Neal Rogge, Conservation Seasonal Tech, effective September 11, 2020. Motion carried.

Motion Miller, seconded by Bush to approve a separation of employment for Douglas Kennebeck, Conservation Seasonal Tech, effective September 24, 2020. Motion carried.

Motion Mummert, seconded by Bush to approve ISG Field Services Invoice #C1745 for submission to Dakota Access Pipeline for payment of inspection services provided from August 30, 2020 through September 26, 2020. Motion carried.

The supervisors provided committee reports and reviewed meeting schedules.

Mongan called for comments from the public. Stu Hogg reported on behalf of the County's Safety Committee that a continuing issue of wasps in the Treasurer's office needs to be addressed. Several attempts have been made over the years to remedy the situation, but it appears to be getting worse. Hogg suggested ways to determine where the problem is originating from with the supervisors supporting any and all efforts to fix the problem.

There being no further business, Vice Chairman Mongan adjourned the meeting at 9:18 a.m.
