The Cherokee County Board of Supervisors met in regular session on Tuesday, February 11, 2020 with Dennis Bush, Rick Mongan, Gary Lundquist, Duane Mummert, and Wane Miller present. Nick Brewer, *Chronicle Times*, represented the press. William Gauthier and Derek Scott were also in attendance. Lundquist reviewed the process to adopt an ordinance under IAC 427B and after conferring with County Attorney Ryan Kolpin, the supervisors reaffirmed prior action taken on January 28, 2020 to adopt Ordinance #2020-01; which will become effective upon publication of the full ordinance.

Motion by Mummert, seconded by Bush to approve ISG Field Services Invoice #C1633 for submission to Dakota Access Pipeline for payment of inspection services provided from December 29, 2019 through January 25, 2020. Motion carried.

Motion by Mongan, seconded by Miller to receive bids until 2:00 p.m. on Friday, February 28, 2020 and to set a public hearing and bid letting on March 3, 2020 at 10:00 a.m. for the 2020 Cherokee County Courthouse Sidewalk Improvements Project. Motion carried.

The supervisors provided committee reports and reviewed meeting schedules.

Lundquist called for comments from the public and none were offered.

There being no further business, Chairman Lundquist adjourned the meeting at 9:25 a.m.
